The development of financial technology (FinTech) and high-tech applications across the globe in recent years have given rise to innovative cross-sector integration of finance and technology and increased the efficiency of financial services. To promote the development of FinTech in Taiwan, incubate FinTech businesses with potential, and cultivate FinTech talents to improve the competitiveness of the finance industry in Taiwan, the Taiwan Financial Services Roundtable has, under the guidance of the Financial Supervisory Commission, established the "Financial Technology Development Fund" with donations from 13 entities including the Bankers Association, Taiwan Securities Association, Chinese National Futures Association, Securities Investment Trust & Consulting Association, Life Insurance Association, Non-Life Insurance Association, Taiwan Stock Exchange, Taipei Exchange, Taiwan Futures Exchange, Taiwan Depository & Clearing Corporation, Financial Information Service Co., Ltd., Joint Credit Information Center, and National Credit Card Center. It is the first public welfare fund established with the resources and powers of the finance industry for the development of FinTech in Taiwan. We hope that the integration of cross-industry resources can achieve economies of scale, accelerate innovation in the finance industry, and demonstrate the capacity for financial innovation in Taiwan.

With the guidance of the FSC, "FinTech Taipei" has become a key annual event supported by the Financial Technology Development Fund. The Executive Yuan has included it as a key strategy for the Financial Development Action Plan. The event is organized by the Taiwan Financial Services Roundtable and Taiwan Academy for Banking and Finance. It integrates the resources of domestic and foreign FinTech companies, governments, academic institutions, and research institutions and makes use of regulatory technology (RegTech), artificial intelligence (AI), blockchain, virtual reality, and big data technologies. It provides domestic and foreign financial institutions, IT companies, and the public with opportunities for cooperation and learning through sensory, experience, and sharing. We hope that FinTech Taipei can be used to create a permanent FinTech innovation and communication platform so that we can jointly bear witness to Taiwan's potential in FinTech development.



Industry Benefits

Expand Taiwan's FinTech ecosystem and bring together the finance and technology industries to create cross-sector value and co-create a platform for exchanging ideas.



International Benefits

Make FinTech Taipei an exhibition brand for international FinTech innovation and combine the capacity for innovation in Taiwan and abroad to create synergy for mutually beneficial communication and development.



Talent Cultivation Benefits

Focus on the needs of the participating businesses and integrate FinTech innovations and applications to create a one-stop multi-business and talent matching platform that strengthens cross-sector cooperation and talent exchange in FinTech.

The TFSR established the Financial Technology Development Fund in 2016 to promote the development of FinTech industries, create an innovation and entrepreneurship base for FinTech, incubate FinTech companies with potential, and cultivate FinTech talents. The Fund integrates the resources of the finance industry and makes use of the economies of scale and overall planning. We have established the FinTechSpace, organized FinTech exhibitions, cultivated FinTech talents, and conducted international exchanges and cooperation.

FinTech Taipei was established in accordance with the Financial Development Action Plan announced by the Executive Yuan in 2018. The in-person exhibition was held in 2018 and 2019 and it is now held again after a three-year hiatus. The pandemic has accelerated digital transformation in many industries and led to rapid developments in FinTech. According to statistics published by the FSC, investments by the finance industry in FinTech development will increase sharply this year with an investment of up to NT\$30 billion, which demonstrates the continuous increase in the growth of FinTech.

The key events this year included the FinTech Taipei exhibition, international forums and seminars, FinTech Taipei Awards, announcements by startups, and matchmaking. The FinTech Taipei Awards event was organized for the first time in accordance with the FinTech Development Roadmap of the FSC. It attracted 160 entries from nearly 100 institutions for the Technology Innovation Award, Innovative Business Model Award, Model Co-Creation Award, Global Market Potential Award, and FinTech Investment Award. The top institutions in FinTech will be selected and the award ceremony and demonstrations will be organized during the exhibition to demonstrate Taiwan's capacity for FinTech innovation and help teams with potential for international development step onto the global stage.

With the guidance of the FSC, the sponsorship by donors of the Financial Technology Development Fund, and the support of trade associations, institutions, and other entities of the finance industry as well as the representative offices of foreign countries in Taiwan, FinTech Taipei created record highs in terms of the scale of the exhibition and attracted participants from 17 countries. It has become Taiwan's largest FinTech event and platform for the exchange of ideas. In the future, we shall continue to use diverse resources from domestic and foreign companies, governments, and academic and research institutions to enhance Taiwan's capacity for innovation and strengthen connections with the international community, and empower growth in Taiwan's FinTech ecosystem.

Finally, the TFSR wishes to thank participants from all sectors for participating in the event. We hope that the in-person exhibition this year can overcome the difficulties of the pandemic and bring about more FinTech innovation in the post-pandemic world to create better opportunities for FinTech development. FinTech Taipei 2022 is organized jointly by the Taiwan Financial Services Roundtable and Taiwan Academy for Banking and Finance with the guidance of the FSC in the 5th edition of the exhibition this year. In-person exhibitions were organized in 2018 and 2019 and supported by the people. More than 80,000 attendees participated in the events in 2018 and 2019. Due to the pandemic in 2020 and 2021, the exhibition was held by means of FinTech forums. We invited domestic and foreign experts to attend in-person and online meetings, which also attracted tens of thousands of participants with exceptional results.

FinTech Taipei has withstood the test and challenges of the pandemic with abundant energy. "FinTech Taipei 2022" is expanded in the form of an in-person exhibition in response to the strong support from all sectors as the pandemic subsides. Experts and representatives from more than 200 domestic and foreign financial institutions from the United States, United Kingdom, Canada, Australia, Poland, Israel, Hungary, Turkey, Lithuania, Luxembourg, India, Japan, Singapore, Hong Kong, Denmark and Taiwan will take part in the exhibition.

FinTech Taipei is organized as an in-person exhibition again with "virtual characters in exhibition interactions" so that participants can experience the virtual and real integration of the venue and virtual characters, and experience the true value of services provided by FinTech to satisfy consumer demand. In the professional discussions, the "International FinTech Forum" on the first day focuses on exploring three major themes including digital identity, RegTech, and sustainable finance. The discussions on the second day are based on applications for different settings and technological innovations in the "FinTech Applications Seminars". The forum and seminars include speeches and attendance in panel discussions of a total of 70 experts from 11 countries. The two-day exhibition is expected to attract more than 10,000 visitors and demonstrate the abundance and diversity of FinTech in Taiwan.

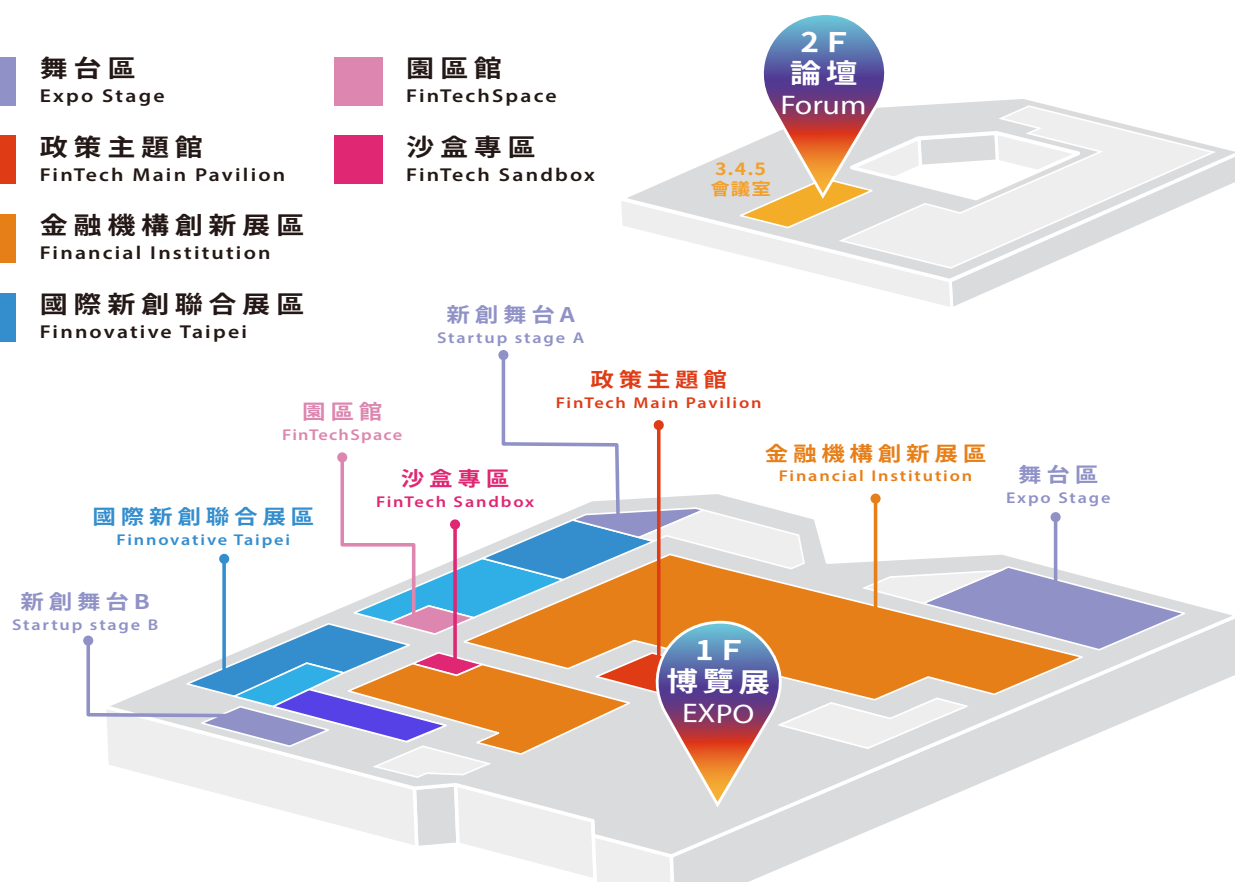
